

Lwv-scv Policies to Review

DIVERSITY, EQUITY & INCLUSION (DEI) POLICY

The LWV St. Croix Valley is fully committed to diversity, equity, and inclusion in principle and in practice. Diversity, equity, and inclusion are central to the organization's current and future success in engaging all individuals, households, communities, and policy makers in creating a more perfect

democracy.

There shall be no barriers to full participation in this organization on the basis of gender, gender identity, ethnicity, race, native or indigenous origin, age, generation, sexual orientation, culture, religion, belief system, marital status, parental status, socioeconomic status, language, accent, ability status, mental health, educational level or background, geography, nationality, work style, work experience, job role function, thinking style, personality type, physical appearance, political perspective or affiliation and/or any other characteristic that can be identified as recognizing or illustrating diversity.

NONPARTISAN POLICY OF THE LEAGUE OF WOMEN VOTERS OF ST. CROIX VALLEY

The League of Women Voters of St. Croix Valley is nonpartisan. As an organization it does not support or oppose candidates for public office, but rather acts only on those issues chosen by the membership for *study and action*. The League believes that political parties are essential to the American system of government and that the participation of informed citizens is beneficial to the political parties and to the system. Consequently, the League encourages its members as individuals to be active in political parties, in finding and supporting candidates for public office, and in seeking election to public office. Members of the League are not eligible to serve on the Board while seeking or holding elected public office. While serving on the Board, a League member shall not seek nor hold state-level elective office, nor shall any officer or Board members allow her/his name to be used in support of any candidate or a state or federal office. In all other political activity, committee members shall participate to the extent the League nonpartisanship is maintained. There are no other restrictions on the political activities of officers and Board members, but it is the responsibility of the Board, individually and collectively, to ensure that the community has no reason to question the nonpartisan position of the organization.

Grassroots Organizing Western Wisconsin (GROWW) is offering a multisession leadership development course in January, 2023, entitled <u>Grassroots</u> <u>School: Organize for Change</u>.

Beth Wood and Irene Bugge, in their capacity as members of our Board of Directors, have registered for this training. Their intention is to bring the leadership skills they learn to our League.

"We believe that everyone has leadership potential and capacity to be a changemaker in their community." Beth and Irene welcome any interested members to look into applying to attend the training with them. Space is limited to 20, so register soon.

GrassRoots School is a leadership workshop for people who want to learn practical skills they can use to organize for change in their local communities.

Participants will learn five basic leadership practices:

- 1. How to articulate a story of why you were called to lead, a story of those whom you hope to mobilize, and a story of action: self, us, and now.
- 2. How to build intentional relationships as the foundation of purposeful collective actions.
- 3. How to structure a team with shared purpose, ground rules and roles for effective leadership.
 - 4. How to strategize turning resources into the power to achieve clear goals.

5. How to translate strategy into measurable, motivational, and effective action.


