(DEIJ) Diversity, Equity, Inclusion and Justice: on the path to new awareness~


Susan Bosley, Irene Bugge, and Barb Wetzel got some insight into a contemporary Ojibwe artist's perception of U.S. historical events

impacting Native sensibilities and experiences.

The exhibition of Jim Denomie's (1955-2022) surreal paintings at Minneapolis Institute of Art gave them pause. The paintings and other pieces, such as sculptures, can be uncomfortable to look at because he confronts our history with biting wit, but none of it untrue. Denomie's spirituality is also prominent. Well worth the time, followed by a substantial lunch at Indigenous Food Lab in Midtown Global Market; Susan, Irene and Barb appreciated getting to know each other better.
