## **Summary of 2026 Planning Meeting**

On November 4, nineteen LWVSCV leaders and members met over Zoom to talk about plans for 2026. Attendees - Beth Wood, Carolyn Saunders, Cindy Glocke, Irene Bugge, JJ Levy, Katrina Larsen, Kay Brooks, Kris Surbaugh, Pat Seidl, Jaye Hay, Kathy Streitz, Barb Katt, Susan Bosley, Karen Roberts, Barb Wetzel, Edna Early, Vicki Harmon, Jarell Kuney. A big thank you to all who attended.

The meeting began with an overview of 2026 Priorities (January – April, 2026). A lively discussion followed about the rollout of HUBz.

#### Priorities for 2026:

- 1. The Unite and Rise 8.5 mass mobilization campaign will continue to be a major focus through November, 2026. We will prioritize and amplify the messaging of Unite and Rise 8.5 at all of our events and try to incorporate the suggested action items into our daily routines. We intend to strengthen our established partnerships with nonpartisan prodemocracy groups in our communities and continue to collaborate with Los Amigos to safely provide food and other necessities to local immigrant families. Writing a Land Acknowledgement statement in collaboration with our tribal community is another DEI goal.
- 2. Voter Services -- voting rights, voter engagement, education, registration and get out the vote will remain the other pillar of our service to the community.
  - a. **Voting Rights: Save Act.** LWVSCV has a presentation on the **Save Act** scheduled for November 10 and a **Lunch & Learn series on Voting Rights and Election Integrity** in collaboration with Frederic Library is planned for January, 2026.
  - b. **Colleges and High Schools**. Over half of the schools in our three-county area have requested services including a voter/registration/information table, online resources, bookmarks with school logo and/or a classroom presentation. There is also interest in organizing questions for our Civics Game by grade level.
  - c. **Candidate Forums and Meet & Greets.** LWVSCV is a co-sponsor (with LWVGCV) of a Dec. 6, 2025 forum with WI Supreme Court Candidates. A meeting with leaders

will be scheduled to determine our volunteer bandwidth to proceed with additional local forums during spring 2026.

- 3. Leadership Review/Redesign with focus on sustainability. A team has been doing an internal review and collecting information from other leagues about their organizational structure. The committee did complete an advisory checklist on political engagement recommendations. They plan to complete their review of our leadership structure and make recommendations that will keep our organization strong and sustainable in 2026. HUBz will be a component of the structural redesign.
- 4. **HUBz** will expand our work and our relationships.
  - **a.** Geographical groups within our LWVSCV Chapter. We plan to empower HUB members to take on League work and lead in each area.
  - b. We have point people and support people who have volunteered in each HUB and this will grow.
  - c. HUBz will be used for Coffees, postcard writing, finding liaisons, and volunteers for our work with high schools, libraries, and events. Communication, distribution, new initiatives, all implemented more locally.
  - d. Supplies: We will split up our supplies between the 4 HUBz for easier access and distribution.
  - e. Boundaries between HUBz can be crossed and HUBz will support each other when needed as we do now across our three counties.
  - f. Hubz will have email groups, phone trees and text threads. These will be created by each HUB group.
  - g. We anticipate support from each HUB for all of our work in Voter Services and our League endeavors.
  - h. We are planning monthly HUB/Voter Services/Member Services Zoom meetings and would like to hear from the HUBz at each board meeting if needed.
  - i. All in process and open for ideas and growth.

## **Election Issues Are Everyone's Issues!**









Fifty-one people attended a fascinating presentation on "Election Issues are Everyone's Issues" by attorney and Hudson chief election inspector, Karry Weaver. Karrie addressed issues related to the SAVE Act, the data on non-citizens voting (non-citizens voting is already illegal in the US and in WI and is practically nonexistent), and voting issues related to the November 2024 constitutional amendment in Wisconsin.

A number of municipal clerks and poll workers along with League members and the general public attended. The recorded presentation will soon be available on the LWV St. Croix Valley website <a href="https://lwvstcroixvalley.org/">https://lwvstcroixvalley.org/</a>

This presentation is the first event generously funded by the 100 Women Who Care Polk/Burnett ( Home) grant of \$2,800. Additional events are being planned including a series of lunch and learn presentations in collaboration with the Frederic Public Library for the four Tuesdays in January 2026.
