The League of Women Voters of **St. Croix Valley** is nonpartisan. As an organization it does not support or oppose candidates for public office but rather acts only on those issues chosen by the membership for study and action.

**The LWVSCV defines sensitive positions as president/co-presidents, Voter Services chair/co-chairs, and communications individuals who represent the League to the media. These positions are the only ones that are authorized to speak for the League. Because of this privilege, they may not participate in all activities that are open to members at large.*

League members at large are in no way restricted from exercising their first amendment right of freedom of expression and involvement in the political activities of their choice as long as they avoid the appearance of the LWV supporting partisan activities.
